

CLUB'S REGULATION

(approved at the meeting on 6 June 2021)

In the following, the term "member" is to be understood as including "attendees" duly admitted by resolution of the Board of Directors.

Article no. 1

The use of the Company's premises and facilities is forbidden for Members who have not fulfilled their obligations towards the Company or who are subject to disciplinary measures of suspension or exclusion. The Registered Office is open during the periods and hours established by the Board of Directors.

The services of the Registered Office may be suspended during the winter period in a manner to be determined year by year. The use of the premises is forbidden during the night from 10pm to 7.30am.

Article no. 2

Access to the Club is reserved for Members who are not in debt and for authorized guests who have been reported to the secretariat. Members will be given a magnetic card for access to the changing rooms; the card is not transferable or assignable for any reason and is only activated after regularization of payment of the annual fee.

Temporary entry permits may be granted at the Member's request for a fee. The amount is determined annually by the CDA. These guests may access all areas reserved for Members with the exception of the Members' toilets; this type of guest differs from the hospitality given to teams and athletes training at the club, for which separate regulations apply. Member's areas: all the areas of the Club are reserved for the actual Member, with the exclusive use of the east-dock area and the changing rooms on the upper floor. Athletes, training teams and accompanying persons may use all the areas except those expressly dedicated to effective Members.

Article no. 3

Non-member athletes are entitled to enter the club only in the sports facilities and structures dedicated to their specific sport.

They are therefore forbidden to pass through areas other than those reserved for the sport practiced as well as to use facilities and structures other than those reserved for the aforementioned discipline, with the sole exception of the bar-restaurant, the offices and the changing rooms on the ground floor.

The rules of behavior set out in these regulations, as well as any further rules laid down in other regulations approved by the General Meeting and/or the Board of Directors, even in the absence of specific reference, shall also be understood as applying to non-member athletes.

Article no. 4

The Member shall use the facilities and services in a manner that does not affect the rights of other Members. The Member may not take materials, tools, sunbeds or other items outside the premises without the express authorization of the BoD.

Article no. 5

The Member owning boats moored at the Club is forbidden to use it for economic, profit-making or other economic purposes, profit-making purposes or purposes other than the statutory mutual purposes (rental, use as a dwelling, etc.); it is also forbidden to use it as a residence or dwelling for oneself or one's guests.

Article no. 6

The behavior of the Member must be constantly polite. Members must avoid any improper behavior, swearing, getting drunk, swearing and unbecoming phrases, as well as aggressive

behavior towards other Members. It is compulsory to wear appropriate, orderly clothing that

respects the places where one attends. Each Member has the right/duty to call the other Member who fails to comply with these elementary rules of civil life to order. It is forbidden to smoke, introduce animals unless they are on a collar, weapons and to play gambling, as well as all those games that conflict with the current rules of public order. It is forbidden to offer food to animals (including fish and birds).

Article no. 7

The Member also has the following duties:

- to respect all equipment and materials belonging to the club, making appropriate use of them and in harmony with any specific regulations drawn up at the unquestionable discretion of the Board of Directors, also on the proposal of the Head of the Prevention and Protection Service at the Head Office;
- no longer occupy chairs, armchairs, sunbeds and deckchairs for personal use only;
- to exercise the most cautious supervision with regard to children under 18 years of age, for whose unlawful acts they are liable under the Civil Code. Children under the age of 14 may only attend the Club if accompanied by their parents or another Member who assumes responsibility for them. The acknowledgement of these Regulations, which are permanently affixed in the premises of the Head Office, implies the explicit exoneration of the Board of Directors and of the Company's staff from any responsibility concerning acts and facts committed by the children of Members under 18 years of age;
- avoid soiling the Club premises with the greatest care. For waste paper, containers, bottles and other types of waste, the appropriate bins and containers must be used.
- Absolutely avoid damaging vegetation and lawns.
- To scrupulously comply with the directives imposed by means of notices in the Head Office and to strictly observe the indications of the signs in the premises

It is also strictly forbidden to keep personal objects in places other than those prescribed for the purpose and specifically intended. In the changing rooms it is forbidden to leave at the end of the day clothes or anything else except in the personal lockers.

Finally, it is absolutely forbidden to use bicycles, motorbikes, scooters and motor vehicles in the clubhouse area; it is also forbidden to use roller-blades, skateboards or similar equipment.

Article no. 8

The Member shall treat the service staff with the greatest respect. All employees are at the service of the Club and not of individual Members. It is forbidden for Members to enter and stay in all service rooms.

Article no. 9

The lockers - duly numbered - located in the changing rooms are rented by the Club/society upon payment of an annual fee. The lockers must be used solely for the storage of personal clothing and must be kept clean at all times. The Company shall not be liable for the items stored in them or for any items left in the changing rooms. If necessary, the locker may be opened at any time by order of the Head Office Manager and/or a member of the Board. At least one Member must be present when the locker is opened and must countersign the note of the objects found. The locker, granted for use to a resigned or excluded Member, shall be vacated in favor of the Club and the objects found therein must be collected by the Member within 7 (seven) days, following prior notice.

Article no. 10

Bicycles must be parked in the reserved space, mopeds and motorbikes in the parking spaces provided by the municipality before the access road to the clubhouse, and cars may be parked in

the area of the club reserved exclusively for Members who have affixed their annual membership sticker clearly visible on the windscreen; the sticker cannot be transferred to third parties. ; the sticker cannot be transferred to third parties. Vehicles must be parked in the spaces provided so

as to minimize obstruction and avoid obstructing ordinary traffic and emergency vehicles. Any violations shall be punishable in accordance with the Code of Conduct.

Article no. 11

The Club is not responsible for any kind of theft of or damage to vehicles, boats, clothes, equipment, etc., towards members or their guests or other people attending the Club.

SPECIFIC BEHAVIOR

Article no. 12

Fishing is forbidden in the places reserved for mooring and the greatest passage of boats and people.

Article no. 13

The use of racing and training boats is reserved exclusively for training crews. All ordinary boats must be used with care and, when any damage is detected on a boat or on the moorings, it must be reported immediately to the staff. Whenever a Member's boat is used, a clear and legible entry must be made in a special register, specifying in legible form the name and surname of the Member who, by signing, assumes full responsibility for any damage caused to the boat. The annotation must be made before use. Members intending to use the boats are obliged to do so on departure and in disarming on arrival, taking the accessories to their place.

Boats shall not be used for any purpose other than those for which they are intended, nor shall they be loaded beyond their capacity. No off-site persons may be taken on board. After use, all boats must be thoroughly cleaned. The Member is obliged to check that the necessary safety equipment, if any, is in place.

Article no. 14

Members under 18 years of age may not use the boats or other social vessels unless accompanied by another Member of age who assumes full responsibility.

Article no. 15

Guests may access recreational boats, provided that they are accompanied by an adult Member. The Member is responsible for the persons and things carried, as well as for the behavior and damage that may be caused by the same.

Article no. 16

The Board may authorize the Member to keep at mooring or storage, in the places strictly indicated, a boat that he owns privately, provided that he signs the mooring contract prepared by the Club. The Member is not entitled to any compensation from the Company for damages that, for any reason whatsoever, are suffered by his boat. The purpose of the mooring requests must satisfy the statutory purposes. Their use for profit-making purposes is prohibited. Members must respect the spaces reserved for other Members and avoid placing their boat in a place where it may hinder the exit of others. Members who have been allocated spaces in racks are required to return them to their place at the end of the day of use.

Article no. 17

The Club's boats are used in the manner, times and forms established by the Board of Directors.

Article no. 18

In the event of particularly important events and entertainments, access to the premises may, at the sole and unquestionable discretion of the B.o.D. or the Internal Manager of the Prevention and Protection Service, also be regulated in ways other than the ordinary ones.

Article no. 19

The Board of Directors has the faculty to reserve, on certain days and at certain times, the sports facilities exclusively for athletes in training and/or for initiatives organized by the Board itself.

Article no. 20

It is forbidden to enter the changing rooms and showers with bottles and glass containers. It is forbidden for children over 6 (six) years of age to enter the ladies' changing rooms. It is also forbidden for girls over the age of 6 (six) to enter the men's changing room. It is forbidden to enter the indoor or outdoor area of the restaurant in a swimming costume or other loose clothing.

Article no. 21

All initiatives by Members that have as their object use other than the ordinary use of the equipment and/or facilities of the Association are subject to the approval of the Board of Directors.

Article no. 22

Spouses or companions or guests of Members, as well as children of full age who are not Members themselves, are not entitled to attend the location, except for the previous payment of the guest fee within the regulatory limits.

Article no. 23

For all matters not contemplated in these Rules and in the Code of Conduct, the Board shall decide and the resolutions shall be notified to the Members by means of notices posted on the Company Register.
